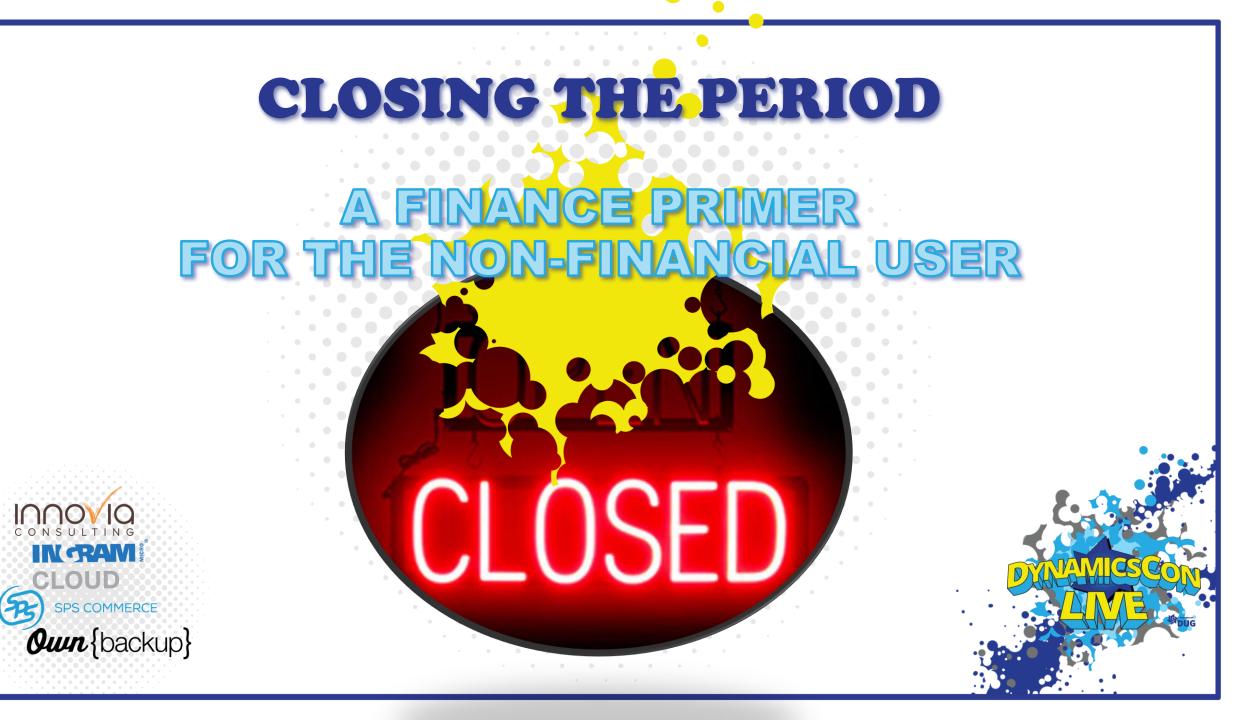

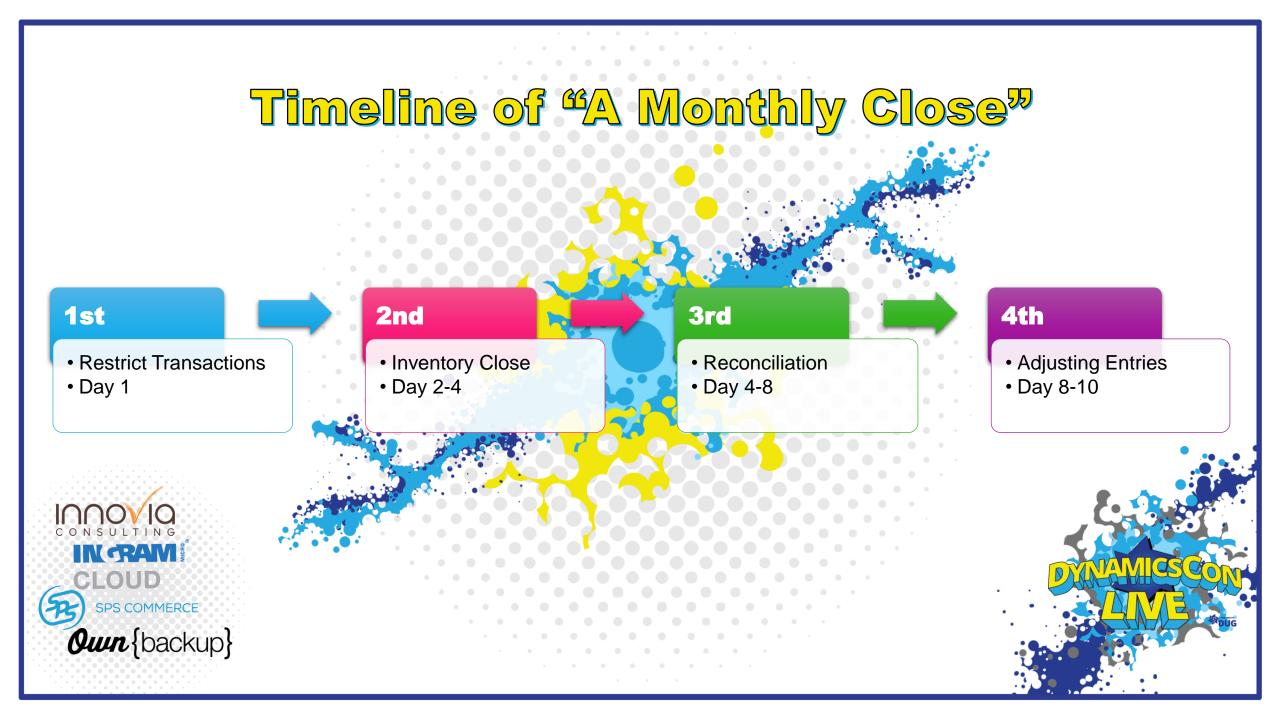

# Inventory Close Day 2 to 4

- The inventory close process settles issue transactions to receipt transactions
  - Based on the inventory valuation method assigned to item model group
  - Before close or recalculation, issue transactions are posted at the calculated running average cost price

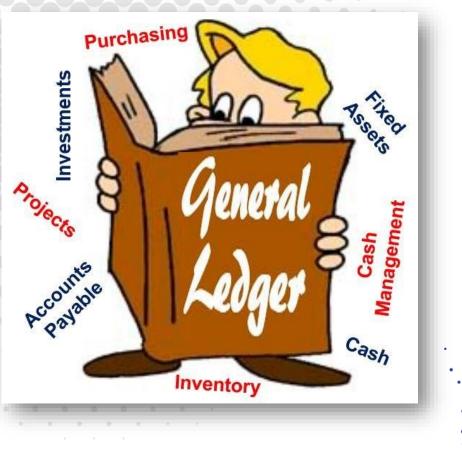

Day 8 to 10

#### The Debits must equal The Credits!

General Journal and Advanced Leger Entry



#### General Journal / Advanced Ledger Entry

#### General Journal (GJ) / Advanced Ledger Entry (ALE)

Post financial transactions directly to general ledger accounts as well as other accounts, such as bank, customer, vendor.

Can be set to auto-reverse

#### GJ

ALE

Can be used as a traditional double entry

Offset accounts controlled by posting definitions

Developed for Public Sector Controlled by posting definitions
